**RESICLEANER** is a versatile multi-purpose detergent having a high cleaning power, specifically formulated for daily cleaning DRACO resin floors. **RESICLEANER** is indicated for manually or mechanically cleaning all the resin surfaces both in industrial and in commercial/domestic environment. It provides brightness to the surfaces, by extending their life. **RESICLEANER** has a delicate and persistent natural scent, it is easy to use, as it requires no rinsing, moreover it leaves no residues or halos of any kind.

## BENEFITS

**RESICLEANER** is a multi-purpose detergent for resin floors having a high cleaning power and with the following features:

- ✓ **EASY TO APPLY:** RESICLEANER is easy to apply both manually and by mechanical means.
- ✓ **EXCELLENT CLEANING POWER:** RESICLEANER thoroughly cleans without being aggressive to the treated surfaces.
- ✓ **SPECIFIC FOR RESIN COATINGS:** RESICLEANER cleans the coatings made up of DRACO epoxy resin, polyurethane resin and resin-cement formulas, by respecting the superficial microstructure and providing the natural gloss without modifying the colours or treatment duration.
- ✓ **WITHOUT RINSING AND WITH QUICK DRYING:** RESICLEANER requires no rinsing and dries quickly, thus permitting immediate use of the floor.
- ✓ **IT LEAVES NO RESIDUES OR HALOS:** RESICLEANER is easy to apply and leaves no stripes, stains or halos.
- ✓ **NON-TOXIC/NOXIOUS:** RESICLEANER is not hazardous to humans and to the environment as per EC Regulation No. 1272/2008 and later amendments.



## AREAS OF APPLICATION

The high cleaning power of **RESICLEANER** makes it particularly suitable to:

- ✓ the daily cleaning of resin floors made with **EPOPLATE**, **EPOLEVEL**, and with the resin systems **DRACOFLOOR** or of resin-based floors at large.

## PREPARATION

Dilute **RESICLEANER** with 0.5 ÷ 3% of water according to the degree of grease and dirt present on the floor.

## PRECAUTIONS

No special precautions for normal use are required. However proceed according to the good operating practices. Use rubber gloves and avoid direct contact with eyes and skin. In case of accidental contact, carefully wash with running water the parts of the body which came in contact with the product and seek medical advice. Product for professional use. Before use carefully read the material safety data sheet.

## HOW TO USE

- ▶ **Clean the surface** to be treated and check that no loose parts or residues of dust have remained.
- ▶ **Manual application:** on small surfaces it is possible to apply the product manually, spread **RESICLEANER** on the area and exert a continuous friction with mop, either linear or with fringes.
- ▶ **Mechanical application:** pour a diluted solution of **RESICLEANER** into the tank and use the product with washer-drier.
- ▶ *In case of stubborn dirt it is recommended to use RESICLEANER HD.*

## COMPOSITION

It contains anionic and non-ionic surfactants, aliphatic alcohols, cleaning adjuvants.

**RESICLEANER** is an EPD (Environmental Product Declaration) product. The content of this formula is compliant with the criteria of biodegradability established by EC Regulation No. 648/2004 on detergents. **RESICLEANER** is not hazardous as per EC Regulation No. 1272/2008 and later amendments.

## PACKAGING AND STORAGE

**RESICLEANER** is packaged in:

- 1 kg bottles
- 5 - 10 kg cans

If the product is stored properly in its original packaging, indoors in a dry location, it maintains its original features for one year. Avoid storing the product at temperatures above 40 °C.
